### 7. POSITION STATEMENT FOR CLINICAL AUDITS

The position statement was finalised and posted on the website. Document to be included in the updated procedure manual.

### 8. STUDENT REPRESENTATION

E. Malatji, a third-year diagnostic radiography student from Sefako Makgatho Health Sciences University (SMU) presented his ideas in terms of providing students with information regarding SORSA. His feedback should be useful to inform the NC's decision about the inclusion of student representation on the NC, because student involvement is important. There are very few student members.

### 9. PATIENT SAFETY POLICY

T. Mookrey and Y. Thambiran, (SORSA – Quality and safety task team chair), are currently developing a patient safety policy.

### 10. ETHICAL CODING AND BILLING TASK TEAM

There is a need for a diagnostic radiographer with vast experience regarding general and theatre coding and billing to be a member on the ethical coding and billing task team.

### 11. CONSTITUTIONAL CHANGES

A policy is required to outline each membership category, e.g. the benefits. The constitution is in the process of being revised for approval by members.

### 12. PAST PRESIDENT

The current constitution does not include a past president. This is to be included in the proposed changes to the constitution. There is also a need to tap into the expertise of the past presidents on an ad hoc basis.

### 13. MEMBERSHIP FEES 2026

Ordinary membership fees to be increased by R15.00. The updated membership fees for 2026 to be posted on the website.

### 14. SORSA EDUCATION AWARD

The Education Award will no longer be offered to members.

## 15. POSITION STATEMENT REGARDING THE USE OF WORK LAPTOPS

A position statement is to be developed regarding the use of work laptops for SORSA business. The statement must protect the members' personal information in line with POPIA.

## 16. 2025 SORSA CONGRESS SPONSORSHIP

Eight applications were received by the 30 June 2025 deadline and NC supported the applications.

### 17. NATIONAL TREASURER CELLPHONE AND AIRTIME

A smartphone (<R600) plus R30 airtime to be purchased by the incoming treasurer.



### 18. PLO REPORT

The congress convenor is not limited to the PLO position.

Further research is needed to identify a suitable venue for the next congress, either in or outside Cape Town, in 2027.

Provincial symposia to receive priority in 2026.

### 19. THE SOUTH AFRICAN RADIOGRAPHER

The June 2023 application for DHET accreditation was not approved.

### 20. CPD REPRESENTATIVE'S REPORT

SORSA provides a range of CPD activities. More general/clinical activities are needed on the website. Members need to attain 30 CEUs (25 general +5 ethics CEUs) per year.

# SORSA 1/25 WEBINAR

# 22 February 2025

SORSA's 1st Webinar in 2025 was hosted as a 2-hour virtual event entitled DRLs – Let's do it together. The webinar was held from 08:30 to 10:30 on Saturday, 22 February 2025.

The 2 speakers, namely, Dr Ida-Keshia Sebelego and Prof Chris Trauernicht agreed on a slightly different format for this webinar. Dr Ida Sebelego, the SORSA-DRL task team chairperson, compiled the webinar programme in consultation with Prof Trauernicht. Prof Trauernicht, is the head of the Medical Physics Division at Tygerberg Hospital in Cape Town, as well as an associate professor at Stellenbosch University. He is the current president of the Federation of African Medical Physics Organisations (FAMPO) and also serves on the Accreditation Board of the International Organisation for Medical Physics (IOMP). Chris has north of 150 congress contributions and 30 papers.



He serves as an assessor for the Health Professions Council of South Africa (HPCSA) and has acted as examiner and convenor for the College of Medicine of South Africa. The IAEA has appointed Chris as expert on numerous occasions. Prof Trauernicht was the recipient of the 2020 "International Day of Medical Physics" award for his services to medical physics in the FAMPO region. Prof Trauernicht addressed the audience on; 'What are diagnostic reference levels and what are they used for'? Ida-Keshia has a PhD in Radiographic Sciences from the University of the Free State. The title of her thesis was "Development of local diagnostic reference levels for abdominal computed tomography using size specific dose estimates". Her research interests are image quality for plain radiography, infection control practices in radiography and diagnostic reference levels specifically for computed tomography. She received a staff grant from the Department of Higher Education and Training(DHET) in the year 2015, 2016, 2019 and 2020. She also received the Thuthuka grant for her PhD, tracking grant from the NRF for the years 2020 to 2022. She is currently busy with a post PhD project. Dr Sebelego presented on the 'What and how to for CT diagnostic reference levels'.

The webinar was interactive where the attendees initially completed some prepresentation questions. Once the presenters completed their presentations, there was a practical session where many of the 146 registered attendees (127 SORSA members and 17 SORSA non-members) responded to the questions posed. Thereafter Dr Sebelego checked the responses and explained the concepts where necessary. SORSA members participated for free and non-members had to pay an amount of R100.00. Delegates were also afforded the opportunity to pose questions/comments after the presentations using the 'Q and A' option which resulted in active discussion. The event was accredited for 2-General CEUs.

Attendees also completed a pre-and post-presentation survey, so that SORSA could gauge whether a follow-up workshop was necessary. The aim of this SORSA webinar was to kick-start DRL training. SORSA has embarked on a project to develop National DRLs for South Africa where Dr Sebelego will lead this project on behalf of SORSA. Prof Trauernicht from the South African Medical Physics Society (SAMPS) has agreed that SAMPS will co-operate and collaborate with SORSA on this initiative to establish national DRLs for South Africa. There was excellent collaboration between the attendees and the presenters. Many of the attendees also later indicated (via email) their interest in being included as part of the team to drive the SORSA national DRL initiative.

# SUMMARY OF SORSA OPEN MEETING

# Saturday, 6 September 2025 SORSA-IAFR Congress



The meeting was opened by past president, Riaan van de Venter. Riaan handed over the presidential chain to the incoming president, Ferial Isaacs.

Ferial led the opening meeting.

- •The National Council members (2025-2027) were introduced.
- ·Exco activities (December 2024-May 2025) were highlighted.
- ·South African Radiographer: SORSA's online platinum open access journal was highlighted and the new editor of the journal, Riaan van de Venter, was announced.

The floor was opened for a question and answer session:

- The need to take the Society "back to the people" was highlighted. The need for more in person events in the provinces. PLO, Fozy Peer, indicated that provincial representatives will be hosting provincial CPD events (physical attendance) in the provinces from now until the next Congress in 2027.
- •The need to have all the provinces represented on National Council was mentioned. To which PLO, Fozy Peer, indicated that the current Constitution is in the process of being reviewed in order to combine provinces to form regions in order to have all provinces represented on National Council.
- ·Mention was made about considering the impact of AI (artificial intelligence) on the profession.
- Scope creep was highlighted. Questions were raised regarding justifying the level of training when taking role extension into consideration. The need for the HPCSA to be very specific with regards to training and education in medical imaging in order to protect radiographers and prevent "scope creep".
- The need to include students in the Society was highlighted. It was suggested that the "forced" student membership be introduced. All were reminded that membership was voluntary. It was suggested that a lower rate be offered to HEI who pay for the membership of their students. It was suggested that the Society have student specific events/awards for students. There should be more done in promoting/inviting students to present at the Congress.
- ·A suggestion was made that there should be regular provincial/regional meetings to get members' views and inputs, instead of only biennially at the Congress.
- ·It was suggested that members interested in joining National Council be mentored into these roles on National Council.
- ·The importance of attending HPCSA webinars was mentioned.
- The importance of taking part in HPCSA surveys was mentioned in order for your suggestions/inputs to be heard.
- ·A member thanked National Council for the good/regular communication with members.

As the head of the School of Radiography at King Edward VIII Hospital, Mrs Munro demonstrated exceptional management and leadership skills. Many of her former students have gone on to lead radiography services and educational programs in countries such as the United Kingdom, Canada, Australia, and New Zealand.



# SORSA-IAFR 2025 Congress

SORSA Congress Convenor Fozy Peer

In its 74th year, the Society of Radiographers of South Africa (SORSA) has once again demonstrated its commitment to professional excellence, innovation, and global collaboration by hosting the SORSA-IAFR 2025 Congress in partnership with the International Association of Forensic Radiographers (IAFR).

The SORSA-IAFR 2025 Congress, held from 5 to 7 September 2025 at the Century City Conference Centre in Cape Town, marked a new pinnacle in the society's legacy and reaffirmed South Africa's position as a key player in the international radiography and forensic imaging community.

With a daily attendance of 372 delegates, the congress drew participants from across the globe — representing 30 countries from across Africa, Europe, the UK, Asia, Australia, New Zealand, and the Americas — creating a truly multicultural and multidisciplinary platform. Delegates included radiographers, forensic pathologists, medical physicists, paediatricians, dentists, and radiologists, all contributing to the rich academic and clinical dialogue.

# Global representation and prestige

The presence of the President, Prof Napapong Pangnapong, of the International Society of Radiographers and Radiological Technologists (ISRRT) and the ISRRT Vice-President of the Europe-Africa Region, Hakon Hejmly, alongside speakers from global bodies such as the International Association of Forensic Radiographers (IAFR), International Atomic Energy Association (IAEA), the International Commission on Radiological Protection (ICRP), the African Regional Cooperative Agreement (AFRA), Nuclear Medicine Research Infrastructure (NuMeRi), the South African Association of Physicists in Medicine and Biology (SAAPMB) and the Institute of Forensic Medicine in Zurich, elevated the congress to a world-class standard. Many of the presenters formed a part of the global representation of 20 invited speakers for the SORSA general radiography tract and 13 for the IAFR tract.

We were honoured to host Prof Laetitia Rispel, the National Research Foundation of South Africa Research Chair on Health Workforce for Equity, and Quality, who very eloquently provided the keynote address entitled, Connecting the Dots: Radiographers, Human Rights, and the Global Health and Care Worker Compact.

Three highly successful forensic radiography workshops were held, two of which took place at the congress venue and one at the Wildlife Forensic Academy (WFA). These sessions were particularly valuable for local radiographers, offering them critical hands-on training in a growing area of forensic imaging practice.

# SORSA FREE STATE SYMPOSIUM

# 10 May 2025

On 10 May 2025, Taahirah Mookrey (SORSA Free State representative) hosted a CPD symposium at the Central University of Technology, Free State (CUT). There were 6 presenters at the symposium: 3 presenters were from the clinical setting in the fields of diagnostic radiography, radiotherapy and nuclear medicine, presenters were from the academic setting. Five of the 6 presenters were physically present and presented in person, also interacting with the audience during the question and answer sessions after each presentation. One presenter presented virtually by means of a pre-recorded presentation, and allowed for questions by the audience to be submitted to the presenter via email after the presentation. There were a total of 23 attendees, which included 2 students. Of the 23 attendees, 10 attendees were members of SORSA. The attendees were from the Free State and Northern Cape

provinces.



The symposium started with registration at 08:00 and ended at 12:30. Upon arrival attendees were welcomed with warm beverages, water and gifts to choose from the exhibition table. Attendees used this opportunity to catch up with colleagues seen long last. The opening of the symposium was done by Mrs Cindy la Grange, previous SORSA Free State Branch Chairperson. The programme director for the symposium was Ms Sylvia Mokuoane, a diagnostic radiographer and current Communications student. The first session was concluded with a tea break at 10:00. During the tea break attendees had warm beverages (tea/coffee) and each attendee received a prepacked breakfast pack which included a croissant, muffin, chicken roll, apple, muesli and yoghurt. The breakfast packs and beverages were provided by a catering company, who were present at the symposium attending to all catering needs. The second session started after the tea break, at 10:20. Throughout the symposium, attendees were provided with bottled water and sweets.

A monetary donation of R1500.00 was also received from NC Radiology. The venue was free of charge as I managed to book the venue at the CUT through the colleagues at the CUT Radiography programme.

Although the number of attendees was low, the symposium was a success. This symposium was the first face-to-face CPD event hosted by SORSA in the Free State after the pandemic. The attendees enjoyed the opportunity to come together with like-minded professionals to share ideas on improving the profession. This symposium brought together radiographers from diagnostic, radiotherapy, nuclear medicine and the academic world. A high light of this symposium was to see how interactive all the attendees and presenters were with each other on the topics being presented. After this symposium, I have once again realised the importance of professionals physically coming together and having meaningful discussions on topics being presented. # **SORSA GAUTENG SYMPOSIUM**

# 12 April 2025

Ms. Khomotso Motiang (lecturer) and Mr. Enos Malatji (3rd year student radiographer), both members of the Society of Radiographers of South Africa (SORSA), organised and hosted SORSA Gauteng Symposium on Saturday 12 April 2025 at SMU. The event was the first in person SORSA continuing professional development (CPD) event in Gauteng post Covid-19 pandemic. The event was accredited by the HPCSA for 4 general continuous educational units (CEUs), and was open to qualified and student radiographers.

The Symposium was aimed at reestablishing and fostering collaborations, and creating a culture of continuous education. This impactful Symposium brought together radiographers in the state and private hospitals and mining industry; student radiographers and librarians from Gauteng and North-West Province, and featured a dynamic blend of presentations on evidence-based practices, evidence synthesis and the role of SORSA. Ms. Motiang delivered a presentation about SORSA on behalf of the SORSA Public Liaison Officer (PLO), Dr Fozy Peer, a renowned academic, world radiography leader and former president of the International Society of Radiographers and Radiological Technologists (ISSRT). Dr Peer's presentation highlighted the history of SORSA and the society's commitment to advancing the profession through evidence-based practice and lifelong learning. The symposium served as a platform to engage with current issues in medical imaging, exploring research gaps, innovations and best practices in radiography and fostering collaborative opportunities to support continuous professional development (CPD) among radiography professionals.

The oral presentations were delivered across the following thematic areas: Breast Imaging, Systematic Literature Review Radiation Safety, Paediatric Imaging and Forensic Imaging. Ms. Kabelo Kgarosi, SMU's Library and Information Services manager, delivered a lecture titled "Best Practices for Evidence Synthesis in Radiographic Research". Ms. Kgarosi's lecture was insightful and thought-provoking, challenging us on the significant gap on evidence-based research outputs in radiography profession in South Africa as compared to our global peers. Ms Kgarosi's lecture reminded our colleagues in the state, private and mining sectors that evidence synthesis is not the exclusive domain of academics and encouraged colleagues who are not in the academia to collaborate with academics to produce quality and impactful reviews. She assured us that we are not alone in this journey and that the librarians are there to guide us through the maze of databases, grey literature, and methodological frameworks. "On behalf of SORSA, I want to express our deep gratitude to Ms. Kagarosi for her contribution to the success of our symposium. Her message will resonate far beyond this symposium and inspire stronger partnerships between radiographers and librarians, and greater commitment to quality evidence synthesis in our future work." said Motiang. I also like to thank Mr. Kgothatso Mabelane (final year student radiographer) and Mr. Kagiso Mnisi (SMU alumni and Comserve Radiographer), both SORSA Members, for the professional manners in which they executed the program as the masters of the ceremony (MCs)".



Ms. Motiang in her presentation titled "Forensic Imaging and Image Evaluation" promoted reflective practice and by encouraging participants to reflect critically on their current practices to identify research gaps and areas for improvement within the profession, aligning with the HPCSA's vision of cultivating healthcare professionals who are thoughtful, responsive, and engaged with evolving evidence and community needs, to maintain professional competence and improve healthcare services delivery. Following the recent revised HPCSA's guidelines on CEUs compliance over a 12-months period, this Symposium aimed to make CDPs accessible to assist radiographers to comply with the HPCSA.

The SORSA Gauteng Symposium 1-2025 would not have been possible without the hard work and sacrifices of the presenters: Mr. Moyayabo Makgato (Radiation Safety Champion), Mrs. Zanele Ngobese (Paediatric and MRI Radiographer at Nelson Mandela Children's Hospital), Mrs. Phuti Mathikithela (Mammographer and Clinical tutor at (DGMAH) and Ms. Naledi Golulu (final year student radiographer). Words cannot fully express how grateful we are for making our Symposium a success, said Motiang. I would also like to thank the radiographers and students who attended the symposium, building networks and collaborations. It was encouraging to see the students' interest and their participation, and appreciating of this platform to discuss their professional matters and know more about their profession. This was the first SORSA symposium to be held at SMU, and we hope to make it an annual event to build partnerships and make CPD events more accessible in the various regions.

This Symposium was free for SORSA Members, and R120 for radiographers and R50 for students who are not SORSA Members, aligning with the SORSA's mission, "to provide access to continuing education opportunities for its members and actively encourage in continuing professional advancement of radiographers".



# THREE SORSA MEMBERS RECEIVED NRF RATINGS

The National Research Foundation (NRF) rating system is a tool managed by the NRF. Individuals submit a portfolio of evidence (POE) demonstrating their research outputs for an eight-year period as well as the impact thereof. Additionally, an evaluation of the quality of their research as well as future research plans must be included in the POE. Applications are then reviewed by a panel of reviewers, nationally and internationally, in line with the requirements of the specialist committee to which an applicant has opted to submit their application for consideration. To submit an NRF rating application the applicant must have a doctoral degree. Once the review process is completed, an applicant will receive a particular rating. This rating depends on when the applicant completed their doctorate, their age at time of application as well as their research standing relative to their peers in their areas of research, globally. The following categories of ratings can be obtained:

- ·A-ratings are for researchers considered to be leading international researchers and experts in their field.
- ·B-ratings are given to scholars considered to be internationally acclaimed researchers for their ongoing international and national contributions to their field of study.
- ·C-ratings are obtained when scholars are considered to be established researchers in their field.
- ·P-ratings are given to scholars 35 years and younger and have completed their doctorate less than five years at the time of application. This is known as the prestigious awards. This rating is awarded on the basis that the panel projects that the researcher is likely to become an international leader in their field of study.
- ·Y-ratings are given to researchers younger than 40 years and completed their doctorate less than five years at the time of application. This rating category affirms that the scholar has the potential to establish themselves as a researcher in their field of study towards becoming a leader in their field.
- Each of the five main rating categories have sub-categories to differentiate the applicants' standing. The NRF rating is valid for six years after which an individual must re-apply for re-rating.

In South Africa at the moment there are only five NRF rated radiographers, three of which are SORSA members.
